## **Rehousing Updates**

So far, we've successfully assisted 26 households and 19 adult children in securing new properties. A big thank you to everyone who has met with us and shared their household needs. However, there are still a few households we have yet to hear from. We urge you to get in touch as we want to ensure that we are providing the proper support for your household.

# **Adult Child Offer**

Regarding the adult child offer, we want to provide some clarity following our last newsletter about refusals. Last month, we said that if adult children refuse two properties after bidding, their application will be suspended. A refusal is when you are offered a property after viewing it, and you choose to decline. Withdrawing your bid and declining to view the property will not count as a refusal.

We encourage you to keep on bidding, and the regeneration team will look to provide more information that is available on Home Connections. However, please bear in mind that some photos will be taken prior to the completion of the void works.

We also want to express our gratitude to those who attended the Spring Planting event on Saturday 14th April. It was wonderful seeing you all, and we hope the entire Juniper community will enjoy the garden once it's in full bloom.
